DPV Return Codes

Z4, DPV No Stat	Indicates whether the address is a vacant property, it receives mail as a part of a drop, or it does not have an established delivery yet.	Y = Confirmed - Do not mail
Z4, DPV Vacant	USPS records indicate that although this may be a valid address, the residence or business is vacant.	Y = Confirmed - Do not mail
